Before and After Care Enrichment

Enrichment Services are not a drop off service and must be scheduled in advance. They are available on a first come, first serve basis. We require a two week notice to cancel services for any day or time. Time may not be available if you would like to continue services on a later date.

Payment is due bi-weekly on Fridays. Tuesday, a \$10 late charge will be assessed. All services paid are non-refundable. Children with unpaid balances will be dropped.

Early Enrichment – 3 years old by September 1st to 12 years old

Early Enrichment is prior to the beginning of class from 7:00a.m. until your class starts. \$3.75 an hour and is paid bi-weekly on Friday, in advance of services rendered. Write the time your child will need care on the specific days.
